STOP!WAR ON POOR...

For the second time in recent months, a demonstration near Tompkins Square Park in New York City has led to mass arrests. On April 1st, police began evicting squatters who had taken over an abandoned six-story apartment building at 316 E. 8th Street for shelter a few years previously. The Buildings Department had ordered the building torn down on the false premise that it was in "immediate danger" of collapsing. The evictions prompted a scuffle between the police and protestors, six of whom were arrested and charged with obstructing governmental administration, criminal trespassing and resisting arrest.

By early afternoon, a demolition crew was at work tearing down the building while one of the ex occupants. 52-year-old Tya Scott, stood crying on the sidewalk: "The inside was beautiful. The city doesn't even have homes for people who are homeless. Why are they doing this?" At 2:25 the protestors moved to the Christadora House, a 16story luxury condominium which some area residents say represents the increasing gentrification of the East Village neighbourhood. Within minutes, 15 police cars had converged on the block. Rocks were thrown through the building's glass lobby doors and the window of a second-floor apartment.

and a bag of garbage was dumped in the lobby. Three more protestors were arrested on charges of rioting. Two of the three were also charged with attempted assault and resisting arrest, and the third was also charged with burglary and criminal mischief.

Tompkins Square Park was the scene of a melee last August, in

which hundreds of angry protestors clashed with police officers whose overly brutal conduct drew mass media censure. The issue was a midnight curfew in the park, the core of a community where the forces of poverty and gentrification have collided in recent years. The Christadora House was also attacked in that uprising.

and DRUG WARS!

It is impossible to determine the exact circumstances of what happened in Thailand on February 20. At the time, the press reports only told us that an RCMP corporal, Derek Flanagan, had been killed in Thailand while attempting to make a drug arrest. A little later. Toronto Scum columnist William Stevenson wrote that Flanagan's death had been arranged by U.S. Drug Enforcement Agency officials because he knew too much about the role of U.S. covert warfare specialists in encouraging the drug trade of Thai warlord (23-2-89 p11.) It has been known, at least since the Iran Contra scandal, that the U.S. government has been using huge drug profits to finance wars against various third world populations that can't get public funding from Con-

gress. Anyone who still believes in the System would have expected the Canadian government to censure Stevenson if this story were false, or to demand an explanation from the Americans if it were true, but it has remained silent.

More recently, a couple of alternative versions of Flanagan's death were published in a front page Globe and Mail story (10-4-89.) One is the official RCMP version that he died on duty as the result of "an accident" during a drug smuggling investigation in Thailand, which resulted in the arrests of five Thais and one Canadian in Thailand and of six Quebecers in Canada. The other is that of the jailed Canadian, who says that Flanagan and two other Mounties enticed him into arranging

The A.L.F. strikes again!

The Animal Liberation Front raided a rabbit breeding and testing laboratory in Soquel, Calif. on March 9, 1989, liberating 40 rabbits. E-Y Laboratories also had their premises and property damaged by paint and paint stripper. -SC Sentinel 12/3/89

The A.L.F. also claimed responsibility for two fires and raids on three labs at the University of Arizona in Tuscon, AZ, on April 3, 1989. In a press release, the A.L.F. said they freed over 1,000 animals, including 950 mice, 50 rats, 16 rabbits, 14 guinea pigs and 10 frogs, "from certain torture and death at the hands of University of Arizona students and researchers."

The fires were set in labs in the main campus and at the medical campus, causing over \$100,00 in damage.

The A.L.F. said that many of the animals were "found with open sores and wounds and dying form overdose injections of various substances, (and are) being placed in good homes around the country where they will live free from the invasive curiosity of researchers and vivisectionists."

While researchers are lamenting over some of the mice who they say have a deadly diseases, they fail to reveal the fact that is was the vivisectionists themselves who injected the rodents with the disease. The researchers say that the disease causes severe diarrhea and is fatal to severely malnutritioned people and people with immune deficiency diseases. They say there is no cure as yet. They also say that the mice will recover from this artificially acquired disease within a week to ten days.

This particular A.L.F. group just recently began their work as reported in Ecomedia Bulletin #48 where four dogs were liberated from a lab on Jan. 6, 1989 during the first ever action in Tuscon, AZ.

Fran Trutt: Update

Fran Trutt, the womyn who was entrapped by paid animal rights infiltrators to plant a bomb last November (see Ecomedia #46 - insert), was back in court March 30 for legal proceedings. Her attorney, John Williams, requested that Fran Trutt's personal property be returned to her. The property was taken by Mary Lou Sapone, a Security Perceptions Unlimited (SPU) spy, from Trutt's Queens apartment after her arrest. Assistant State Prosecutor Bruce Hudock said he would decide on this request by the following week. He did agree though to turn over any information he had concerning wages paid by U.S. Surgical Company (U.S.S.C.), which is the vivisection

Greek Anarchists Freed!

After a year and a half in prison, the two Greek anarchists, Clearhos Smyrnaios and Christophoros Marinos were released with a few restrictions imposed on them. During the trial, which lasted for five hours and was post-poned until a later date, it became obvious that the accusations against them were largely fabricated. Key police witnesses did not show up while others failed to recognize the two men as the actual individuals who, for instance, bombed a police station and the ministry of Public Order one night a few years back. In the weeks preceding the trial, anarchists held a barrage of actions including demonstrations, rallies, blocking off main streets and even a motorcycle demo outside the prison which was met by a score of riot cops. The two are in good spirits after their release and vow to keep the struggle going!

The major effort and attention is now being directed toward the extradition hearings of Palestinian fighter Mohamed Hamdan who is wanted by the U.S. government. The decision will be taken on April 18, 1989. In recent months urban guerilla groups have launched a campaign against the justice system. In the meantime Vagelio Vogratzi, accused of transporting drugs in W. Germany, managed to avoid being sent to jail to wait for her trial.

In the general climate of decay and corruption that permeates Greek politics today, the Greek anarchists are launching a campaign against the electoral parliamentary illusion, so the coming months promise to be sizzling!

the deal, paid his travel expenses to Thailand and threatened to kill him if he failed to produce the drugs. Instead of nailing the bigtime operators they wanted, the Mounties managed to jail a few average people for a deal they wouldn't have been involved in had the RCMP not set it up.

These stories aren't really mutually contradictory; it is quite possible that the RCMP enticed some suspected small-time operators into a drug deal in the hope of nabbing their higher-ups, and the U.S. officials intervened to protect their sources of drugs. This leaves unresolved the question of whether Flanagan's death was accidental or murder. What is clear is that one man is dead, several others will rot for years in appalling prison conditions for "crimes" engineered by the Mounties, and the drug trade continues.

Meanwhile, a U.S. president who was himself involved in the Iran-Contra scandal continues to proclaim a

"war against drugs" which is in actuality a "war against the poor." It is the Bush-Noriega/Contra-Crack connection that have created the extreme situation in Washington, which Bush is now using as an excuse to install martial law tactics. When we read in the Toronto Star (4-11-89 pA1) that "for too long...the D.C. government has failed to serve its citizens," we must bear in mind that the "citizens" alluded to are the middle and upper class property owners. This article and others like it avoids the fact that 85% of D.C. citizens are low-income or no-income families living in slums or ghettos (otherwise known as "public housing.")

The government creates an economically crippling situation for a certain class or race, then provides a means of illegal livelihood (in this case drug dealing), then institutes martial law to "protect" the "citizens" against the "criminals." Measures include more and bigger prisons, military in-

volvement, use of the death penalty. eviction of people from they homes, denial of welfare income to people "suspected" of drug activity, and surrounding public housing by fences while residents are forced to produce photo identification to enter the building. This procedure of holding all public housing recipients responsible for the drug trade has already been used in Chicago, and is similar in concept to the "strategic villages" used to imprison third world populations known to be sympathetic to guerillas active in the area. Such tactics enable the police to exercise total surveillance over the residents, and enforce numerous laws. against them that are not drug-related, such as the one preventing mother's allowance recipients from having a lover.

These procedures are among the many mind-fuck methods used by governments to divide, control and disempower people.
